TERMS OF CONTRACT:-

The initial period of contract of teaching faculty will be for 3 (Three) years at the outset, which may be further extended upto 2 (Two) years on yearly basis subject to satisfactory performance. The maximum tenure of engagement/contract will be 5 (Five) years or attaining 70 years of age or joining of regular faculty, whichever is earlier. However, the incumbent would serve the initial first year of contract independent of joining of regular faculties. The contract would be terminable on one month's notice in the subsequent years of contract on joining of regular faculty by regular appointment/promotion.
